Addendum to ProactiveMD Services Agreement

NEW BUSINESS

Highway Department - CR150S Speed Limit Request

Cale Stephens Montgomery County Highway Department reported to the Commissioners that he did a traffic study on CR150 S between SR47 and CR200 W as requested by Building Administrator Tom Klein. Based on the data he collected and with SR47 being 40MPH at that crossroads and CR150 S being 30MPH east of SR47, so he recommend a 45 MPH speed limit from CR200 W to SR47. This closure will leave the other side of Glenway drive open to traffic and the other residents.

Commissioner Guard moved to approve the request to close one-lane of Glenway Drive on September 14, 2024. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

Change Order #1 - Purple Heart Parkway Extension Project - \$217,135.33

This Change Order is to meet the requirements INDOT put on the project to obtain the INDOT RW permit. (change of approach materials, revisions to the signal, etc.) The Change Order is in the amount of \$217,135.33 and it also increases the contract time by 14 days. The PHP Extension Project is a joint project with the City of Crawfordsville and the increase in the contract amount will be divided 50/50 between the City and the County. Commissioner Fulwider moved to approve Change Order #1 for the Purple Heart Parkway Extension Project in the amount of \$217,135.33. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

ORDINANCES

2nd Reading Ordinance 2024-17 - Ordinance Establishing a Stop Sign on Purple Heart Parkway at its Intersection with Ladoga Road - The ordinance

establishes a stop sign at the Intersection of Ladoga Road for the new road construction of the Purple Heart Parkway Extension from SR231 to Ladoga Road. Commissioner Guard moved to approve Ordinance 2024-17. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

Introduction Ordinance 2024-18: Ordinance Reaffirming the County Retirement Beneift Policy

Attorney Taylor stated the policy of Montgomery County for many years has been that all full-time employees and all elected officials, including but not limited to the members of the Board of Commissioners, members of the County Council, and the Coroner, are participants in the Indiana Public Retirement System (INPRS), formerly known as the Indiana Public Employee Retirement Fund (PERF) and that the County would make deposits to INPRS as required by Indiana law. This policy has been articulated in the Employee Handbook, which is incorporated into the County Code. The new section will read as follows:

- (A) Indiana Public Retirement System (NPRS): The County has elected to participate in the Indiana Public Retirement System (NPRS), formerly known as Public Employee Retirement Fund (PERF). The County will make the statutorily required contribution for all full-time employees, other than Police Officers who are covered by their own retirement plan, and for all elected officials, including but not limited to members of the Board of Commissioners, members of the County Council, and the Coroner.
- (B) Full-Time Employees and Elected Officials Ineligible for NPRS: For those full-time employees and those elected officials, who because of prior participation in INPRS as an employee or elected official are ineligible to participate in INPRS in their current capacity or are otherwise ineligible for INPRS, the County will provide retirement benefits equal to INPRS contributions had the employee or official been eligible for NPRS and will provide such benefits by way of a Section 457 plan or other retirement plan.

REQUEST TO SUSPEND RULES AND ADD SECOND READING ORDINANCE

2024-18. Commissioner Frey moved to suspend the rules to add 2nd Reading Ordinance 2024-18. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

SECOND READING ORDINANCE 2024-18: An Ordinance Reaffirming the County Retirement Benefit Policy

Commissioner Frey moved to approve on second reading Ordinance 2024-18. Seconded by Commissioner Guard. Motion carried 3-0 votes in favor.

RESOLUTIONS

Resolution 2024-20: Resolution Approving Corrective Action for Retirement Benefit Funding

Attorney Taylor stated, the Board of Commissioners have learned that an error had been made and that the County failed to make the required contributions for some members of the Board of Commissioners and County Council. The Resolution resolves that the Auditor will make the missed contributions for all current elected officials to INPRS and make additional contributions to INPRS in order to account for any lost growth in the participant's account because of the delayed contributions and the County Administrator will establish a Section 457 plan or similar retirement plan for any of the Commissioners, Council members, or other elected officials who are otherwise ineligible to participate in INPRS because of the rules of INPRS, and the Auditor will make contributions to this plan for the account of each such person as if that person were otherwise eligible to participate in INPRS, including the base contributions which were missed and any additional contributions necessary to account for lost growth in the account because of the delayed contributions.

Commissioner Guard moved to approve Resolution 2024-20. Seconded by Commissioner Fulwider. Motion carried 3-0 votes in favor.

NOW, THEREFORE, **BE IT ORDAINED** by the Montgomery County Board of Commissioners, that the Fair Housing Policy is hereby amended as follows:

Equal Access to Housing in HUD Programs:

Pursuant to 24 CFR Part 5.403 and 24 CFR Part 574.3, the definition of "family" is revised to include families regardless of the actual or perceived sexual orientation, gender identity, or marital status of its members.

Codification The amendments set forth in this Ordinance shall be codified in the County Code under the section for the Fair Housing Policy.

Effective Date This Ordinance shall become effective on passage by the County Commissioners.

Ordinance No. 2024-20

Amending Drug Free Workplace Policy

WHEREAS, Montgomery County has previously adopted a Drug Free Workplace Policy to ensure a safe and productive work environment; and

WHEREAS, Montgomery County is in the process of applying for grants from the State of Indiana Office of Community and Rural Affairs (OCRA); and

WHEREAS, OCRA has identified necessary amendments to the County's Drug Free Workplace Policy to comply with grant eligibility requirements;

NOW, THEREFORE, BE IT ORDAINED by the Montgomery County Board of Commissioners, that the Drug Free Workplace Policy is hereby amended as follows:

Prohibited Drugs Prohibited drugs are defined as illegal substances, including controlled substances as defined in the Controlled Substance Act (21 U.S.C. § 812) and the Code of Federal Regulations (21 C.F.R. §§ 1308.11-1308.15) and prescription controlled substances which have not been prescribed by a licensed physician or dentist for specific treatment purposes for the employee. Abuse of prescription or over-the-counter drugs will also be treated as a substance abuse problem under this Ordinance. This Ordinance prohibits the illegal use, sale, transfer, distribution, possession, or unlawful manufacture of narcotics, drugs, or other controlled substances while on the job or on County premises (including vehicles used for County business). These include but are not limited to marijuana, cocaine, crack, PCP, heroin, LSD, amphetamines, hallucinogens, and barbiturates. Any illegal substances found on such premises will be turned over to the state police and may lead to criminal prosecution.

Reporting Violations Employees must, as a condition of employment, abide by the terms of this policy and report any conviction to the County under a criminal drug statute for violations occurring on or off County premises when conducting County business. Report of a conviction must be made to the County within five (5) business days after the conviction. The County will then notify the appropriate contracting officer within ten (10) days after receiving notice from either the employee or from another source. (These requirements are mandated by the Drug-Free Workplace Act of 1988.)

An employee who is involved with off-the-job illegal drug activity may be considered in violation of this Ordinance. In determining whether disciplinary action will be imposed for this activity, the County will consider the circumstances of each incident, including but not limited to any adverse effect the employee's actions may have on its customers, other employees, the public, or the County's reputation and image.

Codification The amendments set forth in this Ordinance shall be codified in the County Code under the section for the Drug Free Workplace Policy.
