V. Nucor Road WWTP Capacity Analysis Update - Shannon Killion - GAI

Ms. Killion stated she is currently working on the planning phase and on an overlay map of the district and estimating future flow. When the treatment plant reaches 90% capacity IDEM will place the treatment plant on an early warning list. She recommended doing a 75% build-out to wait and see what happens.
