• 2nd Reading Ordinance 2024-29 Ordinance Creating the 2025 Problem Solving Court Grant Fund - \$118,577

This Ordinance establishes the 2025 Vet Court Grant Fund, creating a dedicated financial structure for managing the \$118,577 grant to support the Vet Court Program. The funds will be used for personnel costs, training, and program services aimed at helping veterans involved in the justice system. The ordinance ensures the proper allocation and accountability of these funds for the 2025 calendar year.

### 2nd Reading Ordinance 2024-30 Ordinance Creating the 2025 DOC Drug Court Grant Fund - \$80,441

This Ordinance established the 2025 DOC Drug Court Grant Fund, creating a dedicated financial structure for managing the \$80,441 grant to support the Drug Court Program. The funds will be used for personnel costs, training, and program services aimed at helping the Drug Court. This ordinance ensures the proper allocation and accountability of these funds for the 2025 calendar year.

• 2nd Reading Ordinance 2024-31 Ordinance Creating the 2025 DOC Probation

### Grant Fund - \$164,890

This Ordinance establishes the 2025 DOC Probation Grant Fund, creating a dedicated financial structure for managing the \$164,890 grant support the Probation Department. The funds will be used for personnel costs, training and program services. This ordinance ensures the proper allocation and accountability of these funds for the 2025 calendar year.

• Introduction Ordinance 2024-32 Ordinance Creating the 2025 Problem-Solving Family Recovery Court Grant Fund - \$106,710

This Ordinance establishes the 2025 Problem-Solving Family Recovery Court Grant Fund. Montgomery Superior Court 2 has been awarded a grant in the amount of \$106,710 from the Indiana Office of Court Services to cover key program expenses for the 2025 Problem-Solving Family Recovery Court for the 2025 calendar year.

• Ordinance 2024-33 Ordinance Granting the Vacation of a Certain Alleys and Streets in the Unincorporated Town of Kirkpatrick

October 21, 2024, the Board of Commissioners received a request from Roxann Hudson, as Trustee of the Patsy D. Lane Trust to vacate an unimproved alleys and certain unimproved streets in the unincorporated Town of Kirkpatrick, south of the former railroad right-ofway, specifically:

- a. An alley which is adjacent to and south of lots 26 and 27;
- b. An alley which is adjacent to and east of lots 22, 27, 28 and 33;
- *c. A street which is adjacent to and north of lot 23;*
- d. A street which is adjacent to and east of lots 20, 21, 23, 26, 29 and 32; and
- *e.* A street which is adjacent to and south of lots 32 and 33.

The Board of Commissioners conducted a public hearing on the petition on November 25, 2024 and no problem owners appeared to object to the vacations of the alley and street as requested. No objections have been filed. The Board finds that it is in the best interests of the citizens of Montgomery County that the vacations should be granted.

### • Introduction Ordinance 2024-34 Establishing Speed Limit on Purple Heart Parkway between US Highway 231 and Ladoga Road

The addition of a new roadway known as Purple Heart Parkway between U.S. Highway 231 and Ladoga Road has recently been completed; and the Board now finds that the speed limit for Purple Heart Parkway from U.S. Highway 231 to Ladoga Road should set at 30 miles per hour.

### Ordinance 2024-29

### AN ORDINANCE CREATING THE 2025 VET COURT GRANT FUND

**WHEREAS,** Montgomery Superior 2 Veterans Court has been awarded a grant in the amount of \$118,577 for the Veterans Court Program to cover key program expenses for the 2025 calendar year; and

WHEREAS, the Montgomery County Commissioners desire to create a dedicated fund to receive, allocate, and appropriately manage these grant funds for the period from January 1, 2025, to December 31, 2025; and

**WHEREAS,** the Montgomery County Commissioners have reviewed the grant funding and associated program needs and have determined that the allocation of these funds will provide vital services for veterans in the County's criminal justice system.

**THEREFORE, BE IT ORDAINED** by the Montgomery County Board of Commissioners that a new section, Section 35 \_\_\_\_ of the Montgomery County Code, is hereby added to the County Code and that this new section shall read as follows:

### 35. \_\_\_ 2025 Vet Court Grant Fund

(A) Source of Funds. The Montgomery County Board of Commissioners hereby establishes **2025 Vet Court Grant Fund**. The fund is hereby created to receive, allocate, and manage the **\$118,577** grant funds provided for the operation and enhancement of the **Vet Court Program** for the calendar year 2025.

(B) Use of Funds:

- 1. Personnel Costs:
  - Salary for Jennifer York: \$81,077.00
  - FICA (Federal Insurance Contributions Act) for Jennifer York: \$7,267.00
  - INPRS (Indiana Public Retirement System) for Jennifer York: \$9,023.00
  - Group Insurance for Jennifer York: \$8,710.00
- 2. Program Costs:
  - Travel & Training for Vet Court Staff: \$5,000.00
  - Mentor Coordinator for the Vet Court Program: \$6,000.00

• Participant Services (including counseling, substance abuse treatment, and reintegration services): \$1,500.00

(C) Non-Reverting Fund This is a Non-Reverting Fund.

IT IS FURTHER ORDAINED that this ordinance shall be effective upon adoption.

**IT IS FURTHER ORDAINED** that all other provisions of the Montgomery County Code of Ordinances which are not specifically amended by this ordinance shall remain in full force and effect.

**WHEREAS**, the Montgomery County Commissioners intend to establish a dedicated fund to receive and manage the 2025 DOC Drug Court Grant and allocate these funds for specific purposes as outlined in the grant agreement;

## 35.\_\_\_ 2025 DOC Drug Court Fund

(A) Source of Funds. The Montgomery County Board of Commissioners hereby establishes the 2025 DOC Drug Court Grant Fund. The fund is hereby created to receive, allocate, and manage the \$80,441 grant funds provided for the operation and enhancement of the Montgomery County Drug Court Program.

## (B) Use of Funds.

1. Salary for Eric Cutts: \$69,321

- This amount shall be used to cover the salary of Eric Cutts, an employee directly associated with the Montgomery County Drug Court Program.
- 2. FICA (Federal Insurance Contributions Act): \$4,000
  - This amount shall be used for the required FICA payments related to salary contributions for Eric Cutts.
- 3. INPRS (Indiana Public Retirement System): \$4,120
  - This amount shall be allocated to INPRS for contributions to the Indiana Public Retirement System on behalf of Eric Cutts.

- 4. Seminars & Training: \$2,400
  - This amount shall be allocated to fund seminars, workshops, and training opportunities for Drug Court staff, including judges, probation officers, and counselors.
- 5. Cell Phone Reimbursement: \$600
  - This amount shall be used for the reimbursement of cell phone expenses incurred by Drug Court staff as part of the operations of the program.

(C) Non-Reverting Fund - This is a Non-Reverting Fund

  - This amount shall be used to cover the salary of Patrick Gilliland, an employee of the Montgomery County Probation Office.
- 3. FICA (Federal Insurance Contributions Act): \$10,158.00
  - This amount shall be allocated for FICA payments for the employees:
    - *\$5,303.00 for Brock Young*
    - \$4,855.00 for Patrick Gilliland

- 4. INPRS (Indiana Public Retirement System): \$14,871.00
  - This amount shall be allocated to INPRS for contributions to the Indiana Public Retirement System:
    - *\$7,763.00 for Brock Young*
    - *\$7,108.00 for Patrick Gilliland*
- 5. Group Insurance: \$867.00
  - This amount shall be used for Group Insurance premiums:
    - \$434.00 for Brock Young
    - \$433.00 for Patrick Gilliland
- 6. Gas/Fuel: \$1,500.00
  - This amount shall be used to cover gas and fuel expenses for the Probation Office vehicles used in field supervision and travel.
- 7. Travel and Training: \$3,500.00
  - This amount shall be allocated for travel and training expenses, including conferences, workshops, and seminars for Probation Office staff.
- 8. Cell Phone Reimbursement: \$1,200.00
  - This amount shall be used for the reimbursement of cell phone expenses for Probation Office staff, as needed for work-related communication.
- (C) Non-Reverting Fund This is a Non-Reverting Fund.
